CODE OF CONDUCT

This document outlines the Code of Conduct for participants for the full duration of the following event (including any preparatory or follow-up meetings):

Name of the event: Etkiniz Forum – What We Do Not Monitor – Intersectionality: Climate, Gender, Poverty

Place of the event: Seferihisar, Izmir, Turkey

Date(s) of the event: 4-5 June, 2022

The Etkiniz EU Programme (Etkiniz) and its partners practice what they preach: human rights, non-discrimination, participation, intersectionality, nurturing approach are, since the beginning, at the heart of our work. CSO representatives have been involved in various phases of Etkiniz and consulted on activities that have been taking place so far. The Etkiniz Forum will continue in line with good practices established so far in Etkiniz and will promote human rights, non-discrimination, participation, intersectionality, nurturing approach.

In order for all of us to ensure a meaningful, safe and positive experience for the each one of us, we kindly ask you to:

1. **Be mindful of the need to** a culture of support, respect, and appreciation towards each other and each other's work , engage in active listening and never use language or make suggestions that can be perceived as violent or diminishing in any way;
2. **Respect the principle of non-discrimination:** Contribute to an environment that makes each of us feel safe and included. Treat each participants with respect at all times, regardless of age, race, colour, sex, language, religion, political or other opinion, national, cultural, ethnic or social origin, property, disability, birth or other status;
3. **Recognise each other as a rights holder:** Recognise and respect the concept of dignity attached to each one of us as a holder of the full set of human rights and as a unique and valuable human being with and individual personality, distinct needs, interests and privacy;
4. **Keep in mind that some participants may have Turkish as their second language:** Be careful to speak clearly when communicating. Always try to use simple words that everyone can understand and demonstrate respect for each other's views;
5. **Be respectful towards others in your use of social media:** Do not post pictures of others, or communicate their private data without receiving prior consent;
6. **Be aware of and report any situations which may represent a risk to anyone:** Make sure to contribute to a transparent and safe environment and raise any concern that might arise.
